ORDER

1. The Principal, Kadathanad Arts and Science College, Vatakara, Kozhikode had applied for additional affiliation to B.Com Co-operation programme for the academic years 2023-24 & 2024-25. After completing the statutory procedures, the programme was recommended to Government, vide paper read as second, as stipulated in Calicut University First Statutes, 1977.
2. The Government of Kerala accorded Administrative Sanction for starting the programme as recommended by the University vide reference cited third.
3. Thereafter, the Government of Kerala issued the No Objection Certificate for starting the this programme from 2024-25, vide reference cited fourth.
4. Thereupon, the Principal has applied for affiliation to the programme for the academic year 2024-25 along with the affidavit in the prescribed format.
5. Accordingly, the matter of granting provisional affiliation to the additional programme, B.Com Co-operation at Kadathanad Arts and Science College, Vatakara, Kozhikode for the academic year 2024-25 was placed before the Syndicate. The meeting of the Syndicate held on 06.08.2024, considered the matter vide Item No.2024.888* and resolved to grant provisional affiliation to B.Com Co-operation programme in the college, limiting the number of maximum seats as per the statutory provisions.
- 6.The Vice Chancellor has accorded sanction to implement the above resolution of the Syndicate .
- 7.Provisional affiliation to the self financing programme for the academic year 2024-25 , is therefore

granted as detailed below.

8. Orders are issued accordingly subject to the following terms and conditions:

- Affiliation granted is strictly provisional and only for the academic year 2024-25
- The college has to apply for Continuation of Provisional Affiliation for the ensuing academic year remitting the fee fixed by the University.
- Educational agency/college shall abide by the conditions stipulated in the No Objection Certificate issued by Government with regard to procedure of admission, collection of fees and other regulations.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all colleges affiliated to the University of Calicut.
- The Principal shall follow the approved syllabus of the University.
- In the light of directions of Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form.
- Violation of the above may lead to cancellation of affiliation.
