**ORDER**

1. The principals of various Colleges had submitted applications for additional affiliation of programmes for the academic years 2023-24 & 2024-25 and 2024-25 & 2025-26, vide reference cited first.
2. After completing all the statutory procedures, including inspection by the District Level Inspection Commissions constituted for the purpose and after consideration by the Syndicate, eligible programmes were recommended to Government, vide paper read as second to fifth, for obtaining views, as stipulated in Calicut University First Statutes, 1977.
3. The Government of Kerala accorded Administrative Sanction, vide reference cited sixth to ninth, and issued No Objection Certificate, vide G.O cited tenth to fifteenth, for starting new self-financing programmes for the academic year 2024-25, subject to the terms and conditions specified in the said G.Os.
4. On receipt of the Administrative Sanction and No Objection Certificates from the Government, the Principals of the following Colleges have submitted requests for affiliation to the programmes.
5. Considering the matter in detail, the Vice Chancellor has accorded sanction to grant provisional affiliation to the following FYUG programmes under self financing mode during the academic year 2024-25 subject to ratification by the Syndicate

- Affiliation granted is strictly provisional and only for the academic year 2024-25.
- The college has to apply for Continuation of Provisional Affiliation for the ensuing academic years remitting the fee fixed by the University.
- **Provisional affiliation granted for BBA/BCA programmes is subject to the approval of the AICTE. The Principals of the colleges shall ensure that AICTE approval for BBA/BCA programmes is received.**
- **The Educational agency/college shall abide by the conditions stipulated in the No Objection Certificate issued by the Government with regard to the procedure of admission, collection of fees and other regulations.**
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all colleges affiliated to the University of Calicut.
- The Principal shall follow the approved syllabus of the University.
- In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the

institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted to the college will automatically be cancelled.

- Violation of the above may lead to cancellation of affiliation.
