**ORDER**

1. The principals of various Colleges submitted applications for additional affiliation of programmes for the academic years 2024-25 & 2025-26, vide reference cited first above.

2.After completing all the statutory procedures, including inspection by the District Level Inspection Commissions constituted for the purpose and after consideration by the Syndicate, eligible programmes were recommended to Government, vide paper read as second & third, for obtaining views, as stipulated in Calicut University First Statutes, 1977.

3. As per the letter cited fourth, the Government of Kerala informed that it had no objection in starting MBA programme (additional batch) at Sahridaya Institute of Management Studies, PB No.19, Kodakara, Thrissurand, Elijah Institute of Management Studies, Kurichikara P O, Thrissur, subject to the condition that the Institute should satisfy the eligible conditions prescribed by the AICTE and the University.

4. The Government of Kerala accorded Administrative Sanction, vide reference cited fifth and sixth, and issued No Objection Certificate, vide G.O cited seventh to ninth, for starting new self-financing programmes for the academic year 2024-25, subject to the terms and conditions specified in the said G.Os.

5. The Principals of the Colleges concerned submitted requests for affiliation to the programmes as sanctioned by the Government along with affidavit in the prescribed format.

6. Accordingly, Provisional affiliation to the following programmes was granted vide U.O.read as (10) above subject to the terms and conditions as stated therein.

7. Considering the errors crept in in the UO, read as 10, the Vice chancellor has ordered to cancel the same and to issue a revised order granting provisional affiliation to the programmes, as detailed in the table above subject to ratification by the Syndicate.

8. Orders are issued accordingly subject to the following terms and conditions:

- .Affiliation granted is strictly provisional and only for the academic year 2024-25.
- The college has to apply for Continuation of Provisional Affiliation for the ensuing academic years remitting the fee fixed by the University.
- **Provisional affiliation granted for BBA/BCA programmes is subject to the approval of the AICTE. The Principals of the colleges shall ensure that AICTE approval for BBA/BCA programmes is received.**
- **The Educational agency/college shall abide by the conditions stipulated in the No Objection Certificate issued by the Government with regard to the procedure of admission, collection of fees and other regulations.**
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all colleges affiliated to the University of Calicut.
- The Principal shall follow the approved syllabus of the University.
- In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted to the college will automatically be cancelled.
- Violation of the above may lead to cancellation of affiliation.
