ORDER

1. The principal, Ability Arts & Science College for Hearing Impaired, Pulikkal, P.O. Valiyaparamba, Malappuram had submitted statutory application for granting an additional programme (M.Com) for the academic years 2024-25 & 2025-26, vide reference cited (1) above.
2. After completing all the statutory procedures, including inspection by the District Level Inspection Commissions and after consideration by the Syndicate, the new programme was recommended to the Government, vide paper read (2) for obtaining views, as stipulated in Calicut University First Statutes, 1977.
3. The Government of Kerala accorded Administrative Sanction, vide G.O cited (3) and issued No Objection Certificate, vide G.O cited (4) for starting the programme subject to the terms and conditions specified in the said G.Os.
4. On receipt of the Administrative Sanction and No Objection Certificate from the Government, the Principal, Ability Arts & Science College for Hearing Impaired has submitted a request for affiliation to the M.Com programme, for the academic year 2024-25.
5. Considering the matter in detail, the Vice Chancellor has accorded sanction, subject to ratification by the Syndicate, to grant provisional affiliation to M.Com programme with an intake of 12 students, under self financing mode for the academic year 2024-25
- 6.Orders are issued accordingly subject to the following terms and conditions:
 - - Affiliation granted is strictly provisional and only for the academic year 2024-25
 - The college has to apply for Continuation of Provisional Affiliation for the ensuing academic year remitting the fee fixed by the University.
 - The Educational agency/college shall abide by the conditions stipulated in the No Objection Certificate issued by the Government with regard to procedure of admission, collection of fees and other regulations.
 - Admission to the next academic year shall be made only after obtaining prior permission from the University.
 - Conduct of University Examinations of any sort, including that of SDE is compulsory and binding on all colleges affiliated to the University of Calicut.

- o The Principal shall follow the approved syllabus of the University.
- o In the light of directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted will automatically be cancelled.
- o Violation of the above may lead to cancellation of affiliation.
