ORDER

1. The Principals of S.I. Women's College of Arts & Science, Parakkadavu, Kozhikode and Holy Cross Institute of Management and Technology, Eranhipalam, Kozhikode submitted applications for additional affiliation of programmes, remitting required registration fee. After completing all the statutory procedures, including inspection by the District Level Inspection Commission constituted for the purpose and after consideration by the Syndicate, eligible programmes were recommended to Government, vide paper read as second, for obtaining views, as stipulated in Calicut University First Statutes, 1977.
2. Government of Kerala accorded Administrative Sanction, vide reference cited third, for starting new self-financing Arts & Science programmes as recommended by the University and with a direction to the managements of the said colleges for executing agreement with the Government as per the conditions stipulated therein.
3. The Government of Kerala issued No Objection Certificate, vide Government Order cited fourth, for starting new self-financing programmes in Arts & Science Colleges affiliated to the University of Calicut for the academic year 2022-23, subject to terms and conditions specified in the aforementioned G.O.
4. On receipt of administrative sanction and no objection certificate from Government, Principals of S.I. Women's College of Arts & Science and Holy Cross Institute of Management and Technology have submitted requests for affiliation to the programmes, along with affidavits in prescribed format and in stamp paper worth ₹.200/- and challan receipts towards remittance of affiliation fee @ ₹.20,000/- for UG programmes and ₹.25,000/- for PG programmes, for academic year 2022-23. Principals of the aforementioned colleges have also requested to commence classes during academic year 2023-24.
5. Meeting of the Syndicate held on 30.01.2023 had considered the matter of granting provisional affiliation to additional programmes for academic year 2022-23 with permission to start classes during academic year 2023-24 based on request of colleges concerned, vide Item No.2023.51* and resolved to approve the same.
6. Sanction was accorded by the Vice Chancellor to implement the aforesaid resolution of Syndicate.

7. Orders are, therefore, issued for granting Provisional Affiliation to new programmes under self-financing stream in Arts & Science Colleges affiliated to University of Calicut for academic year 2022-23 with permission to commence classes during academic year 2023-24 as shown below.

8. Provisional affiliation granted is subject to following terms and conditions:

- Affiliation granted is strictly provisional and only for academic year 2022-23. Colleges have to apply for Continuation of Provisional Affiliation for the ensuing academic year by remitting fee fixed by the University.
- Educational agency/college shall abide by the conditions stipulated in No Objection Certificate issued by Government with regard to procedure of admission, collection of fees and other regulations, failing which affiliation granted will automatically be cancelled.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to University of Calicut.
- In the light of directions of Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

9. Resolution of Syndicate cited fifth is thus implemented.
