ORDER

- The Educational Agency, Bharatheeya Vidya Nikethan, Kesavamandiram, Kallekkad (P.O.), Palakkad submitted an application for starting a new Un-Aided Arts and Science College for the academic years 2022-23 and 2023-24 vide reference cited first.
- After completing all statutory procedures, including inspection by the District Level Inspection Commission and consideration by the Syndicate, recommendation of the University for starting a new unaided Arts and Science College namely, Bharatheeya Vidya Nikethan Arts & Science College, Kallekkad (P.O.), Palakkad under Bharatheeya Vidya Nikethan, Kesavamandiram, Kallekkad (P.O.), Palakkad for the academic years 2022-23 and 2023-24 with permission to start classes in 2024-25, was forwarded, vide letter cited second, for obtaining views of the Government as stipulated in the Calicut University First Statutes, 1977.
- Based on the recommendation of the University, the Govt. of Kerala accorded Administrative Sanction for the academic year 2024-25, vide G.O. cited third and issued No Objection Certificate (NOC), vide G.O. cited fourth for starting the new Arts & Science College for the academic year 2024-25.
- Thereupon, the Principal submitted a request for granting affiliation to the College for the academic year 2024-25 along with notarised affidavit in the prescribed format.
- The meeting of the Syndicate, vide item No 2024.908* considered the matter and resolved to grant provisional affiliation to the new College for the academic year 2024-25.
- The Vice Chancellor has accorded sanction to implement this resolution of the Syndicate with the following FYUG programmes as detailed below:

- Orders are issued accordingly subject to the following terms and conditions.

- Affiliation granted is strictly provisional and applicable only for the academic year 2024-25
- The College has to apply for continuation of provisional affiliation for the ensuing academic year remitting the fee fixed by the University. Renewal of provisional affiliation in subsequent academic years is subject to submission of the renewed of NOC from the Government of Kerala.
- The Educational Agency/College shall abide by the conditions stipulated in the No Objection Certificate issued by the Government.
- Selection and admission shall be made only on the basis of rules and regulations and the directions issued by the University/Government from time to time.
- The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- Conduct of University Examinations of any sort including that of SDE is compulsory and binding on all Colleges affiliated to the University of Calicut.
- The Principal shall strictly follow the approved syllabii, available on the University website (www.uoc.ac.in) for selecting minor/common courses.
- The Principal shall ensure that all details pertaining to the College are uploaded and updated on the Centralised College Portal.
- In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the Institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, the affiliation granted will automatically be cancelled.
- Violation of any of the above will lead to the cancellation affiliation.
